**Employee Exonerated** - The incident occurred, but the employee acted lawfully and properly.

**Misconduct Not Based Upon The Complaint** - Substantiated misconduct not alleged in the complaint.

**Policy Failure** - The incident occurred, but the employee was following established department policy.
