## Pudding Hill Water Treatment Plant begins operation

Capable of providing 40% of city's drinking water needs

The new Pudding Hill Water Treatment Plant has pumped its

Tuesday, Thursday, Saturday: 8:30 a.m. to 3:30 p.m. first million gallons of water into the city's drinking water system since it came online last week, utilizing the Pudding Hill aquifer for the first time since 2019. Once fully operational, which could be as early as next week, the treatment plant is capable of adding a million or more gallons of water daily into the city's water system, providing 40% of the city's daily water needs.

"Pudding Hill puts us back where we need to be with plenty of water," said Community Services Director John Storer. "Unless we have a substantial region-wide massive drought, we should be fine meeting all city demands moving into the future."

The city will be providing tours of the new water treatment plant during its Open House on Saturday, May 18, from 11 a.m. to 2 p.m.

Some of the mandatory water restrictions in recent years were due to the Pudding Hill aquifer being offline, where the city had to rely on other aquifers during periods of drought. The re-utilization of the Pudding Hill aquifer will allow the city's other drinking water aquifers to rest and recharge. Last week, the city's groundwater consultant provided an overview of Dover's aquifers, which can be viewed here.

The city voluntarily took the Pudding Hill aquifer offline in 2019 when its sentinel monitoring wells detected plumes of PFAS contaminants; however, no PFAS were ever detected in the drinking water pumped from the wells. PFAS seeped into the ground from the former auto recycling plant off Knox Marsh Road that Schnitzer Steel Industries Inc. now owns. As a responsible party, the firm is paying a significant portion of the costs to construct the new treatment plant, with the balance funded by a state PFAS grant.

The Pudding Hill Water Treatment Plant meets and exceeds the U.S. Environmental Protection Agency's new drinking water standards released last month that lowered the threshold of actable limits for PFAS class chemicals.

The plant utilizes granular activated carbon (GAC) to remove all observed PFAS levels. The plant was designed to add additional filtration should there be an issue with a specific PFAS compound or other chemicals. PFAS are perfluoroalkyl and polyfluoroalkyl substances, which have been used in products like Teflon, Goretex, and firefighting foam. The city had begun testing GAC filters in 2018 on about 10 different PFAS compounds, and all were brought down to non-detect levels, noting that GAC is also robust with emerging PFAS chemicals now being investigated.

"The new water treatment plant will be able to treat all PFAS compounds from the Pudding Hill Aquifer to EPA's target goal of zero, or non-detectable per current laboratory standards," Storer said. "Outside of Pudding Hill, the city has not experienced any PFAS issues requiring treatment, highlighting the importance of protecting our aquifers through land conservation or zoning protections."

Groundwater from the Pudding Hill aquifer will be pumped to the treatment plant and treated with caustic soda (sodium hydroxide) and chlorine (calcium hypochlorite). The pretreated water will be filtered through three Greensand Plus filters to remove iron and manganese. Next, hydrogen peroxide is added to the filtered water entering the two ultraviolet light reactors for the advanced oxidation process (AOP) to remove 1,4-dioxane and MTBE (methyl tert-butyl ether). After AOP, the water will be filtered through three pairs of GAC filters to remove PFAS.

# City, plaintiffs appeal redistricting lawsuit to state supreme court

The City of Dover and its co-plaintiffs are appealing a superior court decision that dismissed their redistricting lawsuit against the Secretary of State. The plaintiffs allege the state's redistricting law violates the New Hampshire Constitution.

In late 2023, both parties filed for summary judgment, with Strafford Superior Court Judge Mark Howard holding a hearing on Feb. 7, 2024. In an April 8 ruling, Howard denied the city's motion for summary judgment and granted the state's. Last week, the city and the other plaintiffs appealed the decision to the New Hampshire Supreme Court.

The lawsuit centers around how state legislators drew redistricting maps following the release of the 2020 Census data in 2021. House Bill 50, signed into law on March 23, 2022, groups Dover's Ward 4 residents into two districts combined with other towns. The complaint alleges that Dover's Ward 4, along with other municipalities, including Barrington, Hooksett, Lee, New Ipswich, Rochester, and Wilton, had combined representation with neighboring municipalities despite New Hampshire Constitutional requirements requiring a dedicated district for political wards and towns with sufficient population.

The City of Dover filed the lawsuit against the State of New Hampshire and the New Hampshire Secretary of State on July 26, 2022. The City of Rochester and 10 voters from various municipalities, including Ward 4 Councilor Debra Hackett in her personal capacity and not as a city councilor, have joined Dover in the lawsuit. The plaintiffs' superior court complaint asked the court to either redraw or order the state to redraw the house representation maps for the affected towns and wards in compliance with the state constitution.

The plaintiffs initially sought the New Hampshire Supreme Court to take the case through an original jurisdiction petition to address the matter directly to obtain a ruling on the merits before the 2022 House of Representatives elections; however, the court denied the petition, which led the plaintiffs to file the superior court complaint. The City Council authorized the City Manager to pursue legal action regarding the constitutionality of the redistricting law at its April 27, 2022 meeting.

## Tax bills due June 3

The City Clerk and Tax Collector's Office mailed tax bills to all property owners on May 1. It's the second half of the annual tax bill, due Monday, June 3, 2024.

As calculated and certified by the New Hampshire Department of Revenue Administration, the City of Dover's property tax rate for fiscal year 2024 (tax year 2023) is \$18.70 per \$1,000 assessed valuation.

In addition to mail, property tax payments can be paid online by clicking the "Pay My Bill" button on the home page of the City's website at <a href="www.dover.nh.gov">www.dover.nh.gov</a>. Payment of property tax bills is only available for current year tax bills and is not available for properties with a prior year's tax lien. There are online payment transaction fees collected by the payment processing company.

# Dover Mayor, City Council proclaim May as Mental Health Awareness Month

At the May 8 City Council meeting, Dover Mayor Robert Carrier issued a proclamation declaring May 2024 as Mental Health Awareness Month in the city. The proclamation was presented to Suzanne Weete and Melissa Lesniak, members of the Dover Mental Health Alliance.

"Mental health is an essential part of overall well-being, impacting youth, families, individuals, and those who work in or own businesses across Dover," Carrier said, reading from the proclamation. He noted that one in five American adults and one in six adolescents experience mental health conditions each year.

The proclamation stated, "Despite its prevalence, mental health remains shrouded in stigma, preventing many from seeking help." It encouraged residents to "educate yourself and others about mental health conditions, treatment options, and available resources" and "challenge stigma by speaking respectfully and inclusively about mental health."

Before reading the proclamation, Carrier asked Weete what individuals can do to raise mental health awareness.

"What can we do as individuals is become educated about the impact of mental health challenges and mental illness, not only on individuals, but an entire community," Weete said. "We have to talk about it to normalize this health condition that is a crisis in our country, in our world."

Weete, a volunteer with the Dover Mental Health Alliance and staff member with Community Partners, emphasized the importance of open discussion. "The more we talk about it, the more people feel they're empowered. The more people can ask for help without feeling shame or discrimination," she said.

The proclamation urged residents to "seek help if you are struggling with your mental health and encourage others to do the same." It also called for supporting organizations providing mental health services, creating supportive environments for conversations, and working together "to create a community where everyone feels empowered to prioritize their mental well-being."

After presenting the proclamation, Carrier thanked the Dover Mental Health Alliance volunteers, acknowledging their passion and commitment to this important cause in the community.

# Deadline to change party affiliation before the primary election is June 4

The last day a registered voter can change their political party affiliation before the 2024 State Primary Election is Tuesday, June 4, 2024. Per state law, voters may not change their party affiliation 90 days before a primary.

The Primary Election will be held on Tuesday, Sept. 10, 2024, with the General Election on Tuesday, Nov. 5. At the election, voters will cast ballots for county, state and federal offices.



Voters domiciled in Dover may change their party affiliation at the City Clerk's Office, or any scheduled meeting of the supervisors of the checklist except for during the period between the first day of the filing period for the primary election and the date of the primary election itself.

Voters who have provided their date of birth on a voter registration form may go to the Secretary of State's Registered Voter web link to check their political party affiliation status. The person must enter their first name, last name, town or city, and date of birth, and complete the security entry. If the name, town or city, and date of birth are the same as what was provided in their voter registration form, their name, voter ID, and party affiliation, if any, will be displayed.

# Transportation Lot to be paid parking at all hours starting May 13

Beginning Monday, May 13, the Dover Transportation Lot at 33 Chestnut St. will be paid parking 24 hours a day, year-round. There are no changes to the hourly, daily, or long-term rates.

The City Council approved the change in February following the recommendation of the Parking Commission to better manage the limited parking spaces at the lot.

Drivers may pay at one of the three meters on the lot or utilize the Flowbird mobile phone app to purchase parking. Vehicles left for more than five consecutive days at the lot must be parked in the designated long-term parking section past the building terminal. Meter rates are 50 cents per hour or \$3 per day.

Chinburg Properties owns the lot, which the city leases. Part of the lease agreement allows Chinburg exclusive use of a portion of the spaces for its residential developments. Recently, Chinburg began using 100 of the 300 available spaces at the lot for its renovation of the old courthouse building on Second Street. The spaces marked in yellow are permit parking only. The lease allows Chinburg to utilize up to 200 spaces in total.





The following events are from various historical records, sources, and texts about the

history of Dover.

For more on the history of Dover, visit the Dover Public Library, Locust Street, and the Woodman Museum on Central Avenue. The Public Library also maintains an online collection of historical information located here.

**May 15, 1671** — Richard Waldron and Richard Cooke were chosen as deputies to the General Court on this day.

**May 15, 1732** — New Hampshire Gov. Jonathan Belcher, on this day, approved an act of the Assembly to set apart Oyster River in Dover as a Parish by the name of Durham.

**May 17, 1805** — The turnpike road from Dover to South Berwick opened this year. On this day John Wheeler, the turnpike's treasurer, gives notice to stockholders that the directors have ordered a fourth assessment be paid, and Stephen Sawyer advertises for "30 or 40 stout able-bodied young men" to work on the road.

**May 17, 1862** — The temperature rises to 92 degrees on this day, beginning a days-long heat wave that causes some to suffer from heat stroke.

May 10, 1907 — 66-year-old Jane Wilson was discovered helpless at the B & M railroad station in Dover. Identifying herself as a long-term textile worker from Lowell and Lawrence, Mass., where she worked for 60 years, and a survivor of the Pemberton Mill disaster, she was taken to a local lodging house by order of the county commissioners. The City Marshal, aware of her situation, confirmed that she had recently been an inmate at the almshouse in Tewksbury, Mass., suspecting she might have run away. Wilson told officials she had come to Dover to visit a friend in Rollinsford, only to find her friend absent. Her claim as a survivor stems from the Pemberton Mill disaster, a catastrophic event in 1860 where the mill collapsed in Lawrence, Mass., due to structural failures, killing and injuring many workers. Wilson was sent back to Tewksbury from Dover.

## Ben & Jerry's COO to keynote Seacoast **Chamber Alliance Mental Health Summit**

The third annual Mental Health, Wellness and Recovery in the Workplace Summit, underwritten by Wentworth-Douglass Hospital and sponsored by Kennebunk Savings, will take place Tuesday, May 21, at the Cochecho Country Club in Dover from 8 to 10:30 a.m.

Keynote speaker Mickey Wiles is the founder and chief executive officer of Vermont-based Working Fields, a mission-driven staffing agency that helps individuals overcome barriers to employment and build stable futures. Mickey has had a long career in the private-sector business community where he held various leadership roles including a stint as chief operating officer at Ben & Jerry's. He is in long-term recovery and was provided a second chance after spending time in federal prison. For the last 19 years, Mickey has worked to help others seeking a second chance after living with substance use disorder and/or having experience with justice involvement.


The Mental Health, Wellness and Recovery in the Workplace Summit is designed to help employers explore stigma around mental health and substance use disorder in the workplace. Topics include how to recognize potential mental health or substance abuse issues, how to provide a safe environment for employees to seek help, and resources available for employers.

Additional panelists include LDI Solutions President and Founder Josh Dame Wentworth-Douglass Hospital Assistant Vice President Behavioral Health Services Kellie Mueller, and Cornerstone VNA Vice President of Operations Jennifer Ufkin. Forward Merch, a local entertainment merchandiser, will present a case study about how it successfully draws from the recovery community to fill vacant positions.

Qualified members must show a Geneva Convention common access card (CAC), DD Form 1173 ID card (dependent ID), DD Form 1173-1 ID card or the Next Generation Uniformed Services (Real) ID card for entrance into a participating Blue Star Museum.

## Strafford County Master Gardeners Association announces annual Plant Sale

The Strafford County Master Gardeners Association will host its annual plant sale on Sunday, May 19, from 9 a.m. to 1 p.m. at the Durham Town Hall.

## Utility bills include water service line materials survey

Quarterly water and sewer utility bills again include a survey from the Community Services Department to identify the water service line material used to connect the home or business with the public water drinking system, per federal requirements.

If you have already taken the survey, there is no need to complete it again.

The Water Service Line Inventory Survey, available at <a href="https://bit.ly/service-line-survey">https://bit.ly/service-line-survey</a>, requests water users identify the water service pipe that comes into their home or building and connects with the water meter, take a picture of it, and upload it with the survey. Understanding that many people may not know the exact material, the city created a webpage with images of pipes and their descriptions, also included on the backside of the survey insert. City personnel are also willing to inspect the service line in person to help with the inventory efforts, usually taking 10 minutes or less. There is no cost for this service.

The picture should be of the service pipe coming into the water meter through the wall (though sometimes the floor). It is usually located in the basement. The survey can include up to five photos.

New U.S. Environmental Protection Agency (EPA) requirements have been issued to require all water systems across the United States to create and maintain a public inventory of service line materials in compliance with the EPA's Lead and Copper Rule Revision.
